The only problem we have encountered during the implementation of the project is connected to the global pandemic caused by the novel coronavirus, which cancelled the mobility to Greece scheduled to take place in the middle of March 2020. The activities connected to the educational projects on prevention and early anti-bullying intervention scheduled for March could not be conducted due to the fact that schools have been closed across the country.
